A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARROLLTON, TEXAS, APPROVING THE TERMS AND CONDITIONS OF AN AGREEMENT BY CARROLLTON, AND BETWEEN THE CITY OF TEXAS. AMERISOURCEBERGEN SPECIALTY GROUP, INC., ESTABLISHING A PROGRAM OF GRANTS IN AN AMOUNT EQUAL TO SEVENTY PERCENT OF BUSINESS PERSONAL PROPERTY TAXES PAID ON PROPERTY FOR A MAXIMUM PERIOD OF THIRTEEN YEARS AND A JOB CREATION GRANT NOT TO EXCEED \$1,923,200, TO PROMOTE LOCAL ECONOMIC DEVELOPMENT AND STIMULATE BUSINESS AND COMMERCIAL ACTIVITY WITHIN THE CITY; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH AMERISOURCEBERGEN SPECIALTY GROUP, INC.; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Carrollton, Texas ("City"), has received a request for grant incentives from AmerisourceBergen Specialty Group, Inc., related to job creation and new business personal property as a result of AmerisourceBergen Specialty Group, Inc. ("AmerisourceBergen") occupying up to approximately 450,000 sq. ft. for its regional offices (Phase I-300,000 sq. ft./\$75 million and Phase II-150,000 sq. ft./\$38 million) on approximately 30+ acres of land located at the northwest corner of Plano Parkway and FM544/Parker Road in Carrollton, Texas ("Property"), in order to promote local economic development and stimulate business and commercial activity within the City of Carrollton, Texas; and

WHEREAS, AmerisourceBergen has entered into a lease for the Property for a period not less than ten (10) years during which time, AmerisourceBergen will invest approximately \$15 million in new business personal property ("BPP"); and

WHEREAS, AmerisourceBergen has requested grant incentives for job creation not to exceed \$1,923,200, for the creation of not less than 1,200 jobs and up to 3,000 jobs; and

WHEREAS, AmerisourceBergen has requested grant incentives in an amount equal to a percentage of BPP taxes paid on the new BPP located at the Property above the base year value, for a maximum period of thirteen (13) years, of seventy-five (75%) of the taxable value of BPP; and

WHEREAS, the City is authorized by Texas Local Government Code § 380.001, *et seq*. to provide economic development grants to promote local economic development and to stimulate business and commercial activity in the City; and

WHEREAS, the City Council of the City of Carrollton ("City Council") previously adopted a Tax Abatement Incentive Policy to provide financial incentives to new facilities and/or their enhancement or redevelopment (a Chapter 380 Economic Development Program); and

WHEREAS, the City Council of the City of Carrollton, Texas ("City Council") has adopted, in order to promote local economic development and stimulate business and
