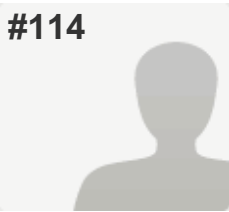

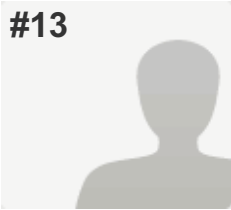

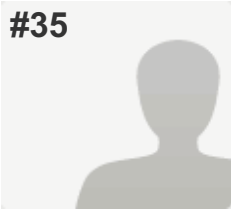
Q6: What do you perceive to be Carrollton's two greatest strengths?

I love the city's focus on creating green spaces and parks, and providing opportunities for recreation for our citizens.

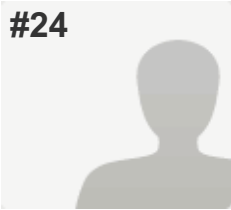
The variety of locally owned restaurants and other businesses in Carrollton demonstrate that it is a haven for small businesses.

Eliminating late fees for all Juvenile Lit (as the Frisco Public Library has done) will not only make our local libraries more accessible to our citizens, but may also not be as cost-prohibitive as it may first seem, since it will reduce some paperwork and administrative duties, and thereby lower other costs.
