A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARROLLTON, TEXAS, TEMPORARILY SUSPENDING IRRIGATION AND PLUMBING PERMIT FEES AS SET FORTH IN ORDINANCE NO. 3977, AND CODIFIED AS CHAPTER 31, "CITY OF CARROLLTON COMPREHENSIVE FEE ORDINANCE", SECTION 31.01 B.2., "SPECIFIC PERMITS", IN THE CITY OF CARROLLTON CODE OF ORDINANCES, IN RESPONSE TO FEBRUARY 2021 WINTER STORM IMPACTS; AND ESTABLISHING EFFECTIVE DATES.

**WHEREAS**, the City Council of the City of Carrollton, Texas ("City Council"), recognizes the substantial impacts of the February 2021 Severe Winter Storm; and

**WHEREAS,** in an effort to relieve some of the financial burden caused by associated storm damage, the City Council will temporarily waive leak-related permit fees to include irrigation and plumbing permit fees as defined Ord. No. 3977, and codified in Section 31.01 B.2 of the Comprehensive Fee Ordinance; and

**WHEREAS**, this suspension of fees applies to permits for certain repairs for residential and commercial customers, and will begin Wednesday, March 3, 2021 at 12:01 a.m., and continue through Friday, June 11, 2021 at 12:01 p.m.; and

**WHEREAS**, all other terms and conditions of Ordinance 3977 and the City of Carrollton Code of Ordinances remain in effect and are unchanged.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CARROLLTON, TEXAS, THAT:

#### Section 1

The above and foregoing premises are found to be true and correct and are incorporated herein and made a part hereof for all purposes.

#### Section 2

The collection of the following enumerated fees, as established in subsection B.2 of Section 31.01, of Chapter 31, entitled "Comprehensive Fee Schedule", of Title III, "Administration", of the City of Carrollton Code of Ordinances, is hereby suspended beginning Wednesday, March 3, 2021 at 12:01 a.m., up to and through Friday, June 11, 2021 at 12:01 p.m:
