BACKGROUND:

This is a City-initiated request to amend the Comprehensive Zoning Ordinance to make various text amendments. Amendments to the text within the Comprehensive Zoning Ordinance are routinely proposed for updates and revisions.

STAFF RECOMMENDATION/ACTION DESIRED:

On November 5, 2015, the Planning & Zoning Commission recommended **APPROVAL** of the proposed amendments. The attached ordinance reflects the action of the Commission.
